ALL APPLICATIONS MUST BE APPROVED.

- PRODUCT PHOTOS: If you are new to FAMO, or are a returning vendor who is planning to sell new/different items from last year, photos of products to be sold must be submitted with your application - **ITEMS MUST BE ORIGINAL-MADE, GROWN, LOCALLY SOURCED.-NO RESELLING OF PRODUCTS PRODUCED/GROWN BY OTHERS. 80% of your inventory must be original-made, grown, created. We will no longer allow vendors to re-sell items only.**

- You will receive a confirmation email when your application is approved.
- Please pay your \$20 non-refundable vendor fee no later than January 23, 2026 to be considered for the 2/1/2026 Pre-Valentine inside event.

VENDOR GUIDELINES -**Please initial each item, that you have read and understood the terms.**

1. Each vendor will be provided a 6 ft table and two chairs. You may bring a folding shelf to place next to your table to extend your product area.
2. Vendors must hold any and all **active licenses/permits** for the sales of their food/beverage goods in accordance with Saint Charles County and follow all city, county, and state guidelines. **I.e., proper weight scales, sales license, tax license etc.**
3. There is electricity on site at no additional charge. Please bring an extension cord. **It is recommended you bring your own battery packs/generator to run your electric.**
5. **No smoking /vaping.**
6. Vendor spaces are final and at the discretion of the market. You will not receive a refund or transfer to a new date if the vendor cancels. **Vendors are required to stay for the entire market. IF the market deems the weather unsafe, we will advise you to leave. Early leaving without permission may result in banning from future markets. IF the market decides to cancel the event due to weather you will be refunded your \$20. Cancellation of this event due to weather will be sent by EMAIL to each vendor by 1/31/2025 mid-afternoon.**

7. SET UP & TEAR DOWN:

- Check in and set up begins 1 hr before the event opens. Please come in the side door (as marked) and go through the kitchen.
- **Each vendor is responsible for their own set-up and tear-down.**
- **Vendors must arrive at the Market no later than 1 hr before the event and be ready to sell at the start of the event. Vendors MUST remain set up until closing time and vacate the Market area within 1 hour.**

8. Vendor space will be assigned by the Market Team. Vendor's vehicles will be parked in the area designated by the Market Team.
9. Vendors will remove all trash from their space before leaving the premises- please use the trash cans the market provides.
10. Vendors forfeit their fee if they do not show up, or decide to cancel attending the event.
11. **Vendors will commit to helping to promote the market to bring in more customers- this means joining our social media sites, sharing posts, posting on their personal business pages, and word of mouth. The more we all contribute the more we all gain! Facebook: @famofallon & Instagram: Famofallon**
12. **Each vendor should have their own personal business/liability insurance to cover any damage to their own goods/products, or to those of other vendors. FAMO is not responsible for any damage caused to or by individual vendors.**
13. **All vendor complaints should be sent to the market by email and will be discussed on an individual basis. Please remember the market "workers" are vendors as well. We are all busy during the event and wish to keep a respectful and pleasant environment at the event.**
14. **Vendors should maintain a professional/upbeat atmosphere at the event. If a vendor is causing disruption, complaints etc to other vendors or customers-the vendor will be asked to leave.**

15. No vendor should walk up and down aisles or in front of other vendors selling their wares. Nor should any signage be placed in the aisles. Customers will come to your booth if you are pleasant and encouraging, no need to "drag" the customers to you. _____

I agree to all terms stated in the Vendor Guidelines section of this agreement. Vendors:

- 3. Vendors may be turned away if they are not previously scheduled, or arrive after 8:30 a.m.**
- 4. All vendor and customer complaints must be handled by email to the board at FAMOFALLON@gmail.com. These matters will be addressed by phone or email within 48-72 hours and will be the final decision of the board.**
- 5. Please maintain your booth, area, demeanor, and products in a professional and friendly manner.**
- 6. We understand that not all vendors will feel their products sell well with this market, and we encourage you to find a market that better suits your needs. We will not offer refunds if there are no sales or if foot traffic is light. We all must do our part in advertising our market and FAMO is an established market in the community.**
- 7. The market strives to have a varied and interesting market blend. With that in mind, we may have several bakers, jewelry makers, and body/beauty product vendors, etc. Keep your products unique and different from everyone else and start your own following. Friendly/professional competition is a good thing.**
- 8. In 2026 we will enforce the rule of the Farmers & Artisan's markets: 80% of the vendor products must be made by the vendor, grown by the vendor etc. There will no longer be re-selling of items purchased elsewhere as the main course of business. These types of vendors do exceedingly well at Flea markets and are encouraged to go to those markets instead.**
- 9. The only non-Farmers/Artisans type of vendors will be our sponsors who support our market, i.e. LeafFilters, etc. and Stray Rescue.**
